I am extremely happy to advise you that we are going ahead with the 2021 Luncheon. This is being held on Saturday November 27th 2021.

Unfortunately, we have to abide to the following instructions.

Due to the vulnerability of many of our older members and in line with Government recommendations we are asking for everyone attending the luncheon, they must provide proof of their double vaccinations. Alternatively, proof of negative Lateral flow test no more than 48 hours before the luncheon upon arrival.

Failure to provide this will mean exclusion from the event.

If you do not have access to a mobile or a computer then I have been told by my GP surgery that you can request a print out of the information they hold about you with regard to your vaccinations.

This will be checked before you can enter the function room area, so if you are ordering tickets for a group of people can you please pass this information on to all of them.

Anyone who cannot provide this evidence will not be allowed into the Luncheon.

While we can't legally enforce the wearing of face coverings, we would also ask if all attendees could wear a face covering throughout their visit, except when eating and drinking or if they are medically exempt.
